Terms & Conditions

1. A non-refundable deposit of 50% is required to hold equipment for date of event. Please send a check and a filled out copy of this document to the address listed below. Final payment is due the day of delivery. We accept cash and/or check. Please make checks out to Watson's Tents & Events.
2. All rental prices include equipment (tents & bounce houses) setup and tear down. Lessee of lighting must provide their own extension cords. A delivery fee of \$7 per mile is assessed for deliveries; based on the address of the event location.
3. For specific setup/delivery times, please call at least 4 days in advance. Otherwise we will deliver as close to the assigned time as possible.
4. In the event of bad weather (severe thunderstorms, tornados, high winds, etc.) please evacuate the tent. Do not attempt to take the tent down. If anything happens please call us and we will take care of it. We reserve the right to take the tent down to prevent equipment, persons and property from any possible harm or damage. We also reserve the right to cancel the order in the event that severe weather doesn't allow for set up or will cause harm to any rented equipment as well as persons or property. In this rare event, your deposit will be refunded in full.
5. No food, drink or chewing gum in or around the bounce house. This will avoid a choking risk and keep the unit clean. Shoes, glasses & jewelry must be removed before using the bounce house.
6. A responsible adult must supervise the bounce house at all times.
7. Always ensure the bounce house is not overcrowded.
8. No pets, toys or sharp instruments in the bounce house at any time.
9. Do not allow anyone to be in the bounce house during inflation or deflation since this is EXTREMELY DANGEROUS.
10. The lessee is responsible for all equipment from the point of delivery until pick up. The lessee will also take full responsibility and will be held liable for any damages that occur to any/all equipment. Lessees will be charged for damage, broken, lost or stolen equipment at the replacement expense.
11. All rented equipment must be free of materials such as water, mud, food, ribbon, tape, balloons, tablecloths, etc. prior to pick up, or a cleaning charge of \$50 will be assessed. A tarp will be provided for your use to cover the bounce house. A \$50 fee will be charged for any bounce houses that are wet upon pick up.
12. Damage to lawn or property may result due to vehicle and trailer weight as well as stakes and other necessary tools to keep tent stabilized. Please have sprinkler system, gas & electrical lines, and any other utility (cable, invisible fence, etc.) lines labeled prior to our arrival.
13. It is required to contact DIGGERS HOTLINE (800) 242-8511 (for tents only) prior to our arrival to have area scanned and marked for underground utilities such as telephone, electric, gas and cable TV. This will prevent any damage to your property and will keep everyone safe.

14. Setup prices are included for tents and bounce houses only. Additional setup/tear down including table & chair placement, light installation, etc. may include a **\$50 setup fee**. This will be discussed with the renter based on number of items rented.
15. By printing, signing and dating the line below, you adhere to the following terms and conditions as described above and indemnify, defend and hold Watson's Tents & Events LLC, it's owners and employees harmless from and against any and all liability and costs incurred by the indemnified parties in connection with any claim arising out of any breach by you of this agreement or the harm/damage to persons and/or property caused by any/all equipment.
